Dear Senators Daines, Heinrich, and King and Representatives Harshbarger, Pingree, Graves, Miller and Davis,

Thank you for your efforts to ensure parity in the Medicare graduate medical education (GME) program through the introduction of the *Fair Access In Residency (FAIR) Act*, H.R. 2314 / S. 2715. This legislation will help strengthen the physician pipeline, support equitable treatment of osteopathic medical students and increase access to patient-centered healthcare in rural and underserved areas. The undersigned organizations strongly support the *FAIR Act*.

Medicare funds 71 percent of all GME. Yet too many federally-funded residency programs frequently exclude or impose burdensome requirements on doctors of osteopathic medicine (DOs). According to the 2024 National Resident Matching Program (NRMP) Program Director Survey, 29 percent of residency program directors never or seldom interview DO candidates, which is required for residency selection. Moreover, almost three-quarters (73 percent) of residency programs mandate osteopathic medical students take the MD licensing exam, the United States Medical Licensing Examination (USMLE).

These practices restrict the specialty choices of osteopathic medical students and frustrate healthcare access by impeding physician distribution. More than half of DOs practice in primary care specialties and 73 percent practice in the state where they do their residency training so restricting access to the profession undermines healthcare in rural and underserved communities.

The *FAIR Act* requires federally-funded GME programs to: (1) report annually the number of DO and MD applicants and accepted residents; and (2) affirm annually that DO applications and

the COMLEX-USA are accepted for consideration. Failure to report these results will result in a two percent (2%) annual decrease in Indirect Medical Education payments.

Osteopathic medicine is one of the fastest growing health professions in the United States and colleges of osteopathic medicine educate 29 percent of all medical students. DOs are meeting our nation's healthcare needs, prioritizing primary care specialties, and practicing in rural and underserved areas where care is in demand. The *FAIR Act* will help remove unnecessary and unfair barriers for DOs and strengthen the healthcare training system.
