Dear Representative/Senator:

As the member organizations of the Federation of Associations of Schools of the Health Professions (FASHP), we are writing to welcome you back to the 116<sup>th</sup> Congress.

As you may be aware, FASHP was created in 1968 as a forum for representatives of health professions education institutions to address education's role in organizational patterns of health care; to encourage effective collaboration among the professions in education and practice; to prepare health professions education for the future; and to serve as a liaison with other organizations sharing an interest in health professions education. FASHP is comprised of 16 associations representing the health professions education community that includes 4,786 programs, institutions, hospitals, and health systems, and more than 1.4 million students, faculty, clinicians, administrators, residents, and researchers.

FASHP looks forward to collaborating with you on policies that strengthen and promote the professional health care workforce and the vital role education plays in supplying the nation with highly-trained health care professionals. As Congress begins its work, our member organizations stand ready to work with you to promote policies that bolster the nation's health care workforce and ensure that Americans have access to high-quality health care services. Furthermore, we respectfully request that Congress supports interprofessional patient care, which has been shown to improve cost effectiveness, quality of care, and patient outcomes. In addition, we urge Congress to prioritize federal health professions education programs, including health professions training under Title VII of the *Public Health Service Act (PHSA)* and nursing workforce development programs under Title VIII of the PHSA.

Additionally, FASHP asks Congress to recognize the importance of financial aid to health professions students as you consider the reauthorization of the *Higher Education Act*. As the nation faces widespread health professions workforce shortages, our growing unmet need demands the training of a diverse health professions workforce to care for all populations, including those in underserved areas. As you know, a diverse, well-trained workforce is essential to answering the health care challenges of the 21<sup>st</sup> century.
