

2010-11 Osteopathic Medical College First-Year Enrollment, by State of Legal Residence

The following three charts display the first-year enrollment of 29 osteopathic medical colleges (COM) and branch campuses by state of legal residence for school year 2010-11. Rows display state of legal residence; read down each column for total enrollment by state. The importance of these data is twofold. We hope to pinpoint the states from which COMs attract their students and show how the COM student population is distributed across the states.

The report titled 2010-11 Osteopathic Medical College First-Year Enrollment, by State of Legal Residence displays first-year enrollment of each COM, broken down by state of legal residence. Looking at the 'CO' row in the 'State' column and reading across, there are 10 first-year students enrolled in osteopathic medical colleges located in Arizona. Alternatively, reading down the 'AZ' column shows first-year enrollment was 1 student from Alaska, 1 from Alabama, 0 from Arkansas.

The report 2010-11 Percent of First-Year Enrollment, by State of Enrollment displays first-year enrollment from each state as a percentage of total first-year enrollment in the states in which there are osteopathic colleges. The columns total to 100%, but percentages of less than 2% enrollment in a college are not displayed for ease of viewing.

The report 2010-11 Percent of First-Year Enrollment, by State of Legal Residence answers the question: Where did first-year osteopathic medical students of a particular state attend school (by state)? It can best be understood by reading horizontally; for example, for first-year students from Hawaii -- 38% attended medical school in AZ and 15% in CA. The rows total to 100%, but percentages of less than 2% are not displayed for ease of viewing.
