The 58 undersigned members of the Health Professions and Nursing Education Coalition (HPNEC) write to thank you for demonstrating support for the Health Resources and Services Administration (HRSA)'s Title VII health professions and Title VIII nursing workforce development programs by joining one or both of the sign-on letters to appropriators led by Representatives Mike Burgess, M.D., (R-Texas) and Diana DeGette (D-Colo.) on Title VII and by Representatives Lois Capps (D-Calif.) and Richard Hanna (R-N.Y.) on Title VIII. HPNEC is an informal alliance of national organizations dedicated to ensuring the health care workforce is trained to meet the needs of the country's growing, aging, and diverse population.

Continuing the investment in health professions workforce development will be key to ensuring access to high quality care for all in light of a growing demand for health professionals; aging Baby Boomers requiring more care; and millions of Americans entering the health care system.

By providing educational and training opportunities to aspiring and practicing health professionals, Titles VII and VIII are the only federally-funded programs that seek to improve the supply, distribution, and diversity of the health professions workforce, filling gaps in the supply of health professionals not met by traditional market forces.

As you may know, 2013 marks the 50<sup>th</sup> anniversary of the programs, a testament to their longstanding success in helping the workforce respond to the nation's changing health care needs over time. Over the years, the programs have continued to adapt to prepare health professionals for new care delivery models and emerging health care challenges, enhancing the size and diversity of the health care workforce and improving access to primary care for children, adults, and seniors. Further, their structure allows them to focus on timely topics such as cultural competency, interprofessional education, and behavioral and mental health issues.

HPNEC is grateful for your support for the critical role these programs play in strengthening access to health care services in rural and urban underserved communities alike. Your support is particularly appreciated as the constrained budget environment threatens to eviscerate the modest federal investment in the programs and reverse progress made in mitigating the nation's health care workforce challenges. We look forward to working with you to prioritize a continued investment in the Title VII health professions and Title VIII nursing education programs in FY 2014.
